★ LEGAL COUNSEL, CEBE AND BOARD DISCUSSIONS

Throughout the Summit, The Council convened several key groups charged with driving the strategic direction and legislative focus of our association. The Legal Counsel Working Group received an NAIC/NCOIL update from our partners at Steptoe, and vetted topics for future exploration and subgroup focus such as CMS changes in 2025, Florida's drug reimportation plan and Section 125 plan developments.

The Council of Employee Benefits Executives (CEBE) heard from PhRMA President and CEO Steve Ubl on prescription drug pricing trends and their impact on commercial insurance brokerage. The group then turned its focus to PBM transparency, the DOL Proposed Association Health Plan rule, a newly formed coalition on end-stage renal disease and ERISA's 50th anniversary. The event concluded on Wednesday with a meeting of The Council's Board of Directors.
